**Pet Fee.** My signature below confirms my authorization of a nonrefundable pet fee of \$10.00 (plus tax) for each pet, each night. Additional fees may apply if damage is found in the room upon check-out. No more than 2 pets are allowed per guest room. \_\_\_\_\_ **Initials**

**Left Alone. Dogs are not allowed to be left unattended in the room when guests leave the property. No exceptions!** I shall keep my dog with me or a designated individual at all times. If I leave my dog unattended in my motel room, I authorize motel staff and third parties retained by the Motel, including, but not limited to, an animal control officer or humane society representative, to enter my motel room to address a disturbance created by my dog. I also understand my credit card on file will be charged a \$150 fee for leaving the my dog in the motel room alone. I further authorize Motel staff and third parties retained by the Motel to (i) remove my dog from my room if they are not able to quell the disturbance and are not able to reach me by cell phone or I am not able to return, or do not return, to my motel room within 10 minutes after the call and (ii) arrange for my dog to be transported to a dog boarding facility and will lead to eviction of the pet and possibly their entire party with no refund. If the guest cannot be reached and the pet must be removed, the cost to relocate the pet will be covered by the registered guest of the room and credit card on file. \_\_\_\_\_ **Initials**

**Noisy or Disturbing Pet.** I shall prevent noise or any other disturbance by my dog in the interest of other Motel guests. Should my dog create noise or any other type of disturbance that generates complaints to the Motel by other occupants or personnel of the Motel, at the request of the Motel Manager/Owner, I shall immediately remove my dog from the Motel and make arrangements to board my dog elsewhere. If the Motel provides compensation to Motel guests affected by my dog, I shall reimburse the Motel for the cost of such compensation.

I understand that should my pet disturb other motel guests, the motel will have no other choice but to refuse further accommodation for my pet. For this reason we ask that you provide us with a cell phone number enabling us to reach you if you are not in the room and your pet is creating a disturbance. Fair warning will be given only once and a non-refundable \$150 charge will be applied to the credit card we have on file if pet is left in room and you have left the property. A second warning will lead to eviction of the pet and possibly their entire party with no refund. If the guest cannot be reached and the pet must be removed, the cost to relocate the pet will be covered by the registered guest of the room. \_\_\_\_\_ **Initials**

### **Cleaning Up After My Pet.**

I shall keep my dog on a leash or in a carrier under my supervision when my dog and I are outside my motel room. When walking my dog on motel grounds, I shall pick-up dog waste and deposit such waste in outdoor receptacles designated for such waste. (They Poop! You Scoop!) Walk your leashed pets on the outskirts of the front of property. Please do not let your dog urinate on flowerbeds in front of the motel. \_\_\_\_\_ **Initials**

**Room Location and Leashed Pets.** I understand that, subject to availability, I will be placed in a pet-friendly room on the first floor. I shall keep my dog out of all food and beverage areas including the office/ lobby area. I understand my pet must be kept on a leash (connected to a human) at all times on the exterior grounds of the motel property. **Unattended pets may be removed from the property at the expense of the pet owner.** \_\_\_\_\_ **Initials**

**Damage and Soiling.** I agree to accept full responsibility for any and all damages and/or soiling caused by my pet during my stay. I understand and shall reimburse the Motel the cost of repairing or replacing the furnishings, fixtures, doors, wall, wallpaper, windows, screens, and carpeting in the Motel and landscaping and outside improvements that are damaged by my dog and shall pay the costs for the repair or additional cleaning requirements (including labor) will be charged accordingly to the credit card provided upon check in \_\_\_\_\_ **Initials**

**Pets Sleeping In Rooms.** Pets are not allowed to sleep on/in beds and/or furniture in guest-room. Puppies are expected to be crated when sleeping. Snowdon Chalet personnel reserves the right to enter a room in which a pet is currently occupying for housekeeping and/or inspection. The bathing and grooming of pets is not permitted in the guest room and guest room bathroom. \_\_\_\_\_ **Initials**

**Service Pets.** Service animals for physical assistance are not subject to the pet fee. However, the owner may be liable if the animal causes any damage. Service animal ID is required to waive the fee. \_\_\_\_\_ **Initials**

By bringing a pet in our facility you are agreeing to the motel's pet policies and to indemnify the motel for any injuries, damage or loss of revenue to the motel or a third party caused by your pet. As the pet's owner/handler, you are responsible for any liability arising from your pet's actions.
